Sub: TANGEDCO - Secretariat Branch - Pensioners/Family Pensioners - Furnishing of Life Certificate - Exemption from Annual Mustering Process for the year 2020 as a special case due to Covid -19 - Clarification issued by the Government of Tamil Nadu - Clarification issued.

Based on the orders of the Government issued in the reference first and third cited, necessary orders have been issued in the Proceedings second and fourth cited that the pensioners/family pensioners are allowed to furnish Life Certificate, Non-Employment Certificate and Non-remarriage/Non-marriage Certificate at any time during the months of **"July, August and September"** **"every year"** for annual mustering instead of "April, May and June" to the Pension Disbursing Officer concerned and also exempting the **Annual Mustering Process** for the **year 2020** as a special case, considering the current extra-ordinary circumstances imposed by the Covid-19 Pandemic respectively.

2. Now, the Government in its letter fifth cited have issued clarifications that both, the personal appearance of pensioners/family pensioners as well as furnishing of Life Certificate, are exempted from Annual Mustering Process for the year 2020. The same has been considered for adoption in TANGEDCO.

3. Accordingly, it is hereby ordered that **both, the personal appearance of pensioners/family pensioners as well as furnishing of Life Certificate, are exempted from Annual Mustering Process for the year 2020.**
